### Spotlight on Ofsted Inspection timetable

### Our Head of Standards, Sharon Jones, has prepared a summary below:

- Changes to the deferral policy are being considered on a case-by-case basis, see here.
- Ofsted have recently announced that they have been given some extra funding by government to catch up on inspections delayed by the pandemic.
- Changes won't affect inspections this academic year which are already planned.
- New funding will enable the timescale to be brought forward- aiming to get to every school once by the summer of 2025.
- Will increase the number of inspections carried out from next September- this will typically reduce the additional timescale from up to 2 years (6 terms) to

#### What does this mean for your school? **Schools Graded Good**

- All good schools will be inspected around 3-5 terms later than they would have been, because of the pandemic.
- This year Ofsted will inspect schools last inspected in the 2016/17 academic year – which is an extension of about 5 terms.

#### **Schools Graded Outstanding**

Inspecting both groups simultaneously, starting with the oldest first- Before 2015 will receive graded (section 5) inspection. After September 2015 will receive ungraded (section 8) inspection.

#### **Schools Graded Requires Improvement and** Inadequate

- Pre-pandemic 30 months, these schools can expect an inspection approximately 5 to 6 terms later than they would have done
- As inspection intervals are shorter for these schools, already on track to reinspect these schools much sooner, so the new changes are unlikely to affect many of these schools
- Monitoring inspections will continue in the usual

#### **New Schools Awaiting Their First Inspection**

- Pre-September 2020 opening, up to an additional 18 months on top of the 3 years
- Opening after September 2020, within the third year of opening

#### **Schools Inspected Since May 2021**

Once a school has had an inspection, it will return to the interval set out in our section 5 school inspection handbook
